

## LL.M. IT/IP Law

The LL.M. course in IT Law and Intellectual Property Rights Law is a one year post graduate course that results with the awarding of a 'Master of Laws (LL.M.)' degree. It has been offered since the Winter Semester of 1999/2000 by the Law Faculty of Leibniz Universität Hannover, within the European Informatics Study Programme (EULISP).

Integrated in this academic year is a period of study abroad at one of the ten European partner Universities in the EULISP network. The course is run by the Institute for Legal Informatics. It is the oldest post graduate course in this specific field of study in Germany.

As the only Legal Masters Programme, the LL. M course in IT Law at Leibniz University in Hannover has been distinguished with the status of assured quality from the Initiative for Excellence of the German Academic Exchange Service.

The Donor Association for German Science and DAAD recognized the Programme as one of the ten best International Masters courses at German Universities/higher education institutes.

The Prizes were awarded to an International Masters Course that offers a special innovative curriculum and a concept, with which the emphasis lies on an interdisciplinary approach, a thorough choice for students in connection with supervision, advice and extensive quality assurance measures and a course with a strong identity.



The competition has up to now been carried out in the years 2006 and 2008 and offers not only an important professional orientation for future students, but also for employers and higher educational institutions.

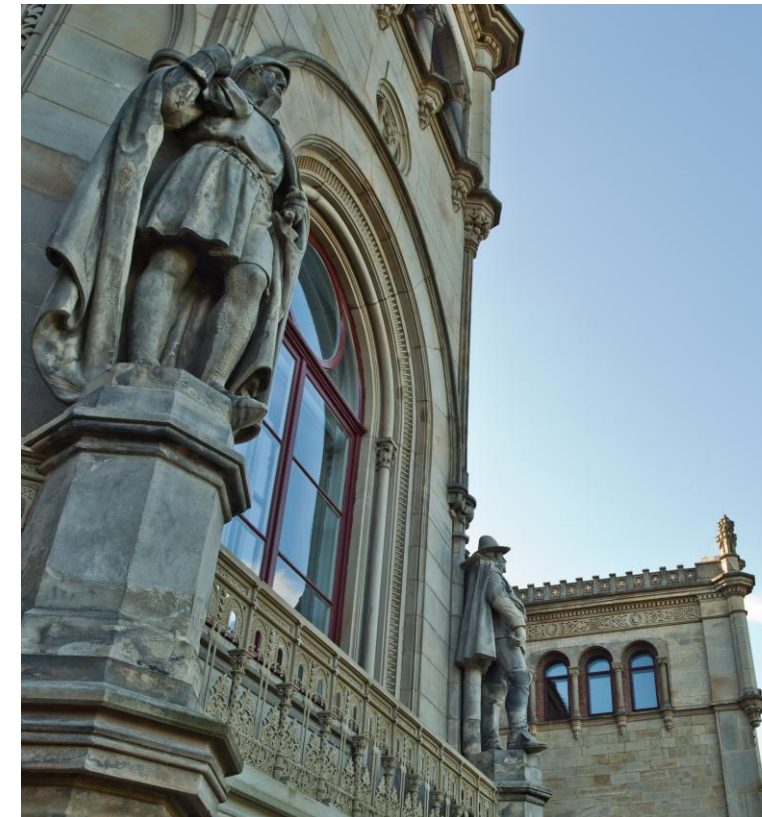

This professional qualification/degree is enhanced during the stay abroad in the 2nd semester at a EULISP partner university and is expected to expand on the IT lawyer's essential soft skills like linguistic competence and experience abroad.



## Structure

The particular topics and branches of law are taught in the winter semester. At the end of the year of studies, as well as taking the accompanying and very practical orientated exams, it is also necessary to complete a Master thesis. The second semester will be spent abroad at one of the numerous renowned partner universities. With well organised planning before and the assistance given during your time studying, along with the EULISP team by your side, this will enable you to have a successful study period.

## Duration of Study

2 semesters (1 is in Hannover and the other is at 1 of 10 other European partner universities- for more information please see [www.eulisp.de](http://www.eulisp.de)).

## Cost

1500 Euros for the 1st semester; the cost of the 2nd semester depends on the chosen Partner University.

## Target group

Committed and qualified Lawyers with State examinations or a comparable legal degree.

## Application date

15th July – for applications from Germany and the EU / 31st May – for Non-EU applicants for the following winter semester.

Therefore in order to take part in this selection process, you will have to apply by the closing date. It is possible to start the LLM course in IT/IP law at the beginning of each winter semester.
